While we would be happy to provide your specialized pharmacy, and laboratory needs, you always have the absolute right to use other providers of your choice. You can be assured, that Dr. Bray or his staff will not treat you any differently, if an alternative facility is used. If, for any reason, you do not find this to be the case, please let us know immediately. Dr. Bray does make part of his living from the ownership of or investment in the above named facilities.

Under Pete Stark II Federal Regulations for durable medical goods, prescription drugs, a physician is not to refer Medicare or Medicaid patients to facilities that he has an ownership interest in. Thus, Medicare and Medicaid patients, of Dr. Bray's are being informed that they are not to use Infusion Plus, Convenience Pharmacy, or the DME services provided in his office for their medical needs and are to use alternative facilities.
